ELIGIBILITY:

- The firms/companies should have minimum 3 years of experience in field of above AMC in PSBs/Regional Rural Bank/Financial Institutions/Govt. offices. (attach copies of service allotment and satisfactory service letter from institution) (Attach copies of service allotment and satisfactory service letter from institution).
- The bidder should have adequate turnover (proof should be attached)/facilities for services/maintenance of UPS AMC.
- The Bidder should have OR will setup local service support office at Bhadohi/Jaunpur/Varanasi/Lucknow/Allahabad
- > The firm and shall provide PAN/GSTIN No. with the bid.
- The firm/Company should not have been blacklisted by any public sector/bank/PSU/Government department in the past. Self-declaration on Rs. 100/- stamp.
- EMD should be submitted.

VALIDITY OF RATES:

- Under the comprehensive AMC, the defective/Non-functioning parts like Logic card, Main Card, Charging Card, Display, Driver Card, Transistors, Transformers, Bypass Rotator Switch, etc. of equipment's spares will be replaced without any cost.
- Earnest Money Deposit (EMD): Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand Only) has to be submitted by the way of Demand Draft I Banker's Cheque/ Pay Order drawn in favour of "Baroda UP Bank" payable at Bhadohi. Earnest Money Deposit will not carry any interest.

EVALUATION OF BIDS:

Quoting incredibly low value with a view of subverting the tender process shall be rejected straight away.

LIQUIDATED DAMAGES:

- The service call will be attended within 24 hours. In case you fail to repair the UPS within 24 hours, you have to provide a stand by UPS till the faulty UPS is repaired.
- In case of delay in attending complaint, liquidated penalty of Rs. 200 per day will be deducted and for delay of more than one week AMC payment for that Branch will be deducted.

SINGLE POINT OF CONTACT FOR SUPPORT:

- Bidder has to provide details of single point of contact viz. designation, address, email address, telephone/mobile No. for communicating and service support as per Annexure-1.
- > At least two engineer dedicated to branches should be appointed.
- The vendor should provide two dedicated engineer, He will be responsible for point contact over Phone, Email and/or Web portal for managing all requests for services, logged by our Branches on all bank working days during the office hours.
- All the calls lodged should be attended within 48 hours.

PAYMENT TERMS:

- Payment will be made by Regional Office on Quarterly basis subjected to satisfactory report of your services.
- Minimum one visit of each branch for preventive maintenance on quarterly basis during AMC period. (Visit Certificate to be countersigned by Branch Heads is Compulsory).
- TDS to be deducted as applicable.

RIGHT TO REJECT BIDS:

- Bank reserves the right to accept or reject any tender or cancel the entire process at any stage without assigning any reason whatsoever. The bank does not bind itself to accept the lowest of any quotation and reserves to itself the right to accept or reject any or all quotations, either in whole or part, without assigning any reason for doing so.
- The selected bidder is found to be unsatisfactory response/performance. Bank can terminate the AMC contract by giving 15 days' notice.

- The registration number of the firm along with the GSTIN no. allotted by the authorities must be submitted.
- PAN number of the firm allotted by the income tax authorities should be submitted. (Without PAN & GSTIN Registration the vendor's bid would become invalid and same shall be rejected).
- > The bid must accompany the income tax returns for the last three years.
- Conditional tenders shall not be accepted on any ground and shall be rejected straight away.
- Any deviation of the conditions given by the purchaser will not be accepted and the bid will be rejected without assigning any reasons.
- The vendor will have to monitor the calls till its resolution. A single point of contact should be available to the I.T. department and branches for regular contact on a single tracking point, from where all the complaints will be managed. The vendor will be require to provide the bank Helpdesk call resolution statistics on monthly basis including new/pending complaints. The details provided should include:

 - 3. Nature of complaint
 - 4. Date and time of first visit with report verified by branch,
 - 5. Present status of complaint
 - 6. Date of resolution of complaint
- If any clarification is required the same should be obtained before submitting the bid.
- The Bank reserves the right to claim as damages from the vendor to the extent of the loss suffered by it, if it is found that due to any commission or omissions of the vendor, damage has been caused to equipment covered by the CAMC or to any property of the Bank even if it is not covered by the CAMC.
- Preventive maintenance should be carried out on quarterly basis.
- Preventive maintenance includes checking of UPS system & condition of batteries attached to UPS system and cleaning or filling of distilled water in the batteries. (Bill of distilled water utilised will be submitted to RO separately)
